Public notice for the expressions of interest of scientists for a permanent position of full professor or associate professor

Art. 1

The University of Palermo is looking for candidates with an exceptional international scientific and teaching reputation and an established excellent academic record through an internationally recognized research program as well as with experience within the third mission area.

This public notice aims at collecting expressions of interest of scientists for filling permanent positions either of full or associate professors.

The submission of expression of interest does not guarantee entitlement for participating in procedures for accessing the qualification of teaching personnel of the University of Palermo.

Art. 2

The following professional profiles are eligible:

- a. scientists who have been working on a permanent teaching or research position in a foreign university or research institution for at least three years, and holding an academic position equivalent to that is applying for, otherwise scientists who have already spent at least a three-year period in researching and teaching in Italian universities through a direct call authorized by MIUR within the" Rientro dei Cervelli" program and achieved scientific results pertinent with the position they are applying for (art. 1, c. 9, law 230/2005);
- b. renowned scientists for the permanent position of full professor (art. 1, c. 9, law 230/2005);
- c. principal investigators of high qualification grants funded by EU or MUR as detailed in the D.M. 28 December 2015 n. 963 (art. 1, c. 9 legge 230/2005);

Scientists, possessing the following profiles, may also apply:

- d. full and associate professors holding the permanent position for at least five years at abroad Universities who will maintain the same academic position, or scientists permanently engaged abroad in research or teaching activities for at least five years who may hold an equivalent academic position (art. 7, c. 5 bis, law 240/10);
- e. research managers and first researchers in public research institutions or people holding permanent positions or fixed-term positions according to art. 1, c. 422 and others of the 27.12.2017 law, n. 205 of the hospitalization and care institutions (IRCCS), carrying out translational, preclinical, and clinical research activities for at least five years at the institutions where they are engaged; for such cases, the national scientific qualification for the respective scientific area and the position level are required (art. 7, c. 5 ter, law 240/10).

Art. 3

The applications have to be sent to directcall@unipa.it including the following documents:

- expression of interest (template attached);
- motivation letter;
- curriculum vitae including a list of publications and a brief description of the most significant publications;
- statement of research, teaching, third mission, an so on (10000 characters max);
- documents showing the correspondence between the Italian and the international academic positions in case it is required according to the above art. 2.

The candidates must present only one application and must apply for a single position indicating one or more academic discipline considered congruent with the scientific activity.

Art. 4

The committee, named by Rector in accordance with art. 2 of the Regulations for direct calls of fixed-term professors and researchers - R.D. no. 4269 of 05/10/2022, makes a preliminar evaluation of the submitted documents in adherence to the expression of interest and identifies the positions characterized by curricula vitae of particular relevance and interest for the University indicating as well the type of procedure to be activated depending on whether the conditions of art. 1, paragraph 9 of Law 230/2005 or art.7, paragraphs 5bis and 5ter of Law 240/2010.

The committee will analyze in different stages the applications from the date of this notice publication during the periods explained below:

period I: 120 days

period II: from days 121 to days 240 period III: from days 241 to days 365

Art. 5

The University shall make public on its institutional website the findings of the Commission's work and, at the same time, send them to the Departments that will examine the results for eventual proposals of call recruitments. Different Departments may express interest in the same positions. Then, after the Academic Senate indication, the Board of Directors makes the resolution for the activation of the procedures referred to art.1 paragraph 9 of Law 230/2005 or art. 7 paragraphs 5bis and 5ter of Law 240/2010, governed by artt. 3 and 4 of the Regulations for direct calls of fixed-term professors and researchers - R.D. no. 4269 of 05/10/2022.

Art. 6
